Integration of ECBC to Building permit Byelaws

2. Building owner should declare the connect load while applying for building permit (Stage 1 of the process)

3. KREDL to send the list of points on what needs to be advertised to public notice on integration of ECBC, this file needs to be put up to Chief Commissioner
4. Town Planning to give points on what can be done at BBMP level on integrating the ECBC and propose of it to Chief Commissioner for approval

Implementation of Energy Efficiency and Energy Conservation Policy

1. Electrical department has submitted Zone wise data on street lights conversion to LED
2. There are currently no projects that specifies on conversion of building appliances to energy efficient.
3. Electrical department and projects department to come up with Annual Action Plan comprising of planned projects on energy efficiency for the following year, 2025-2026
