**Project progress**

1. Drone flying in some part of Yelahanka, Bommanahalli and South zone is pending
2. C40 proposed for a stakeholder discussion on the project, Special Commissioner insisted on having it post the report is submitted to KREDL
3. 87 priority buildings has been identified across all zones
4. All analysis is currently done based on sanction load limit, once the roof saturation analysis is done, it will increase the capacity of solar panels to be installed

**Discussion on calling out tender for the completed analysis**

1. KREDL has been appointed as the nodal agency for solar rooftop installation in Karnataka state
2. A format has been shared by KREDL, to be filled by CSTEP which collects necessary information to call tender
3. A correspondence from MD, KREDL needs to be taken
