Hence, it is hereby directed to all the hospitals, registered under Karnataka Private Medical Establishments (KPME) to mandatorily;

- 1] Register in the Portal (<a href="https://searchmybed.com/#/p/public-portal">https://searchmybed.com/#/p/public-portal</a>) and update real time Data of vacant bed position in category wise. i.e, regular/HDU/ICU/ ICU with Ventilator.
- 2] All hospitals are hereby directed to install a board indicating the above information in a prominent place near the citizen help desk created by BBMP.

All the Hospitals are hereby directed to report compliance of the above directions to the Jurisdictional Health Officer, BBMP failing which appropriate action under the provisions of Karnataka Private Medical Establishments (KPME), Disaster Management Act, 2005 and such other Acts shall be initiated.
