# **ORDER**

Sub: Redeployment of BBMP Marshals for effective enforcement of Covid Appropriate Behavior (CAB) in the city of Bengaluru.

Ref: 1) Govt of Karnataka Notifications No HFW 146 CGM 2020 dated 09-12-2020.

Whereas, the situation of COVID - 19 in Karnataka Bengaluru has been reviewed and it has been observed that there is has been a persistence decline in the number of COVID - 19 cases during the last one month. Further, in view of this improved situation, there is an effort to continue with unlocking process in a scale down manner. There is an urgent need to enforce Covid Appropriate Behavior (CAB) during this unlocking period specially being done in phased manner. Though exhaustive orders on CAB have been issued from time to time, as mentioned above, however there is an urgent need to enforce CAB by all concerned and give adequate awareness. All enforcing agencies have been empowered by Govt Notification vide Govt of Karnataka No HFW 146 CGM 2020 dated 24-03-2021. to enforce above provisions of this notification It is hereby ordered as follows:

1. Redeployment of BBMP Marshals on CAB enforcement duties. 54 Teams of Marshals will be deployed as CAB enforcement duties with immediate effect. The composition of teams is as under:

#### 2. Working Hours

- (a) Shift 1 0600 hrs -1400 hrs
- (b) Shift 2 1400 hrs 2200 hrs
- (c) <u>Shifting of Marshals from Existing duties to CAB Duties</u>. 27 Teams of Marshals Teams for CAB duties will be deployed from Indira Canteen duties and other 27 teams will be composed from Ward Marshal. Whereas Indira Canteen Marshals will carry out shift 1<sup>st</sup> duties, Ward Marshals will do shift 2<sup>nd</sup> duties.
- 3. <u>Areas to be focussed</u>: Markets, Malls, Hotel, Pubs, Main Road Junctions, Theatres, Religious places, Crowded Areas and Low Income Areas, City Parks, Important Roads.

<u>Volunteer Teams:</u> In order to execute CAB in general public, a team of volunteers composing of 28 numbers, have been identified. These volunteers liaison with Marshals/ BBMP staff to implement CAB. Such volunteer may be issued with Identity Card for a limited period primarily to facilitate functioning.

<u>State Police Teams:</u> BBMP will deploy 54 Teams of Marshals for CAB enforcement operations. To strengthen the enforcement in the city, the state police may also deploy its teams along with Marshals to various locations.

Regarding use of Masks in Public Places: Order issued vide No Comm/PSR/243/2020-21 dated 27 Oct 2020 will remain in place.

<u>JHI/ SHI/ MoH</u>: All health officials are hereby directed to carry out CAB enforcement in their respective jurisdiction.
